

**ORDINANCE NO. 2007**

**AN ORDINANCE OF THE CITY OF TERRELL, TEXAS, CHANGING THE ZONING FROM SINGLE-FAMILY TO COMMERCIAL ON PROPERTY DESCRIBED AS LOTS 15 – 30, BLOCK M; AND LOTS 1 – 11 & 29, BLOCK L, KINGS CREEK ADDITION OF THE CITY OF TERRELL, KAUFMAN COUNTY, TEXAS, PROVIDING FOR THE REPEAL OF CONFLICTING ORDINANCES; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.**

**SECTION I.**

**WHEREAS**, the Planning and Zoning Commission of the City of Terrell, Texas held a public hearing on January 18, 2000 and recommends approval to change the zoning from Single-Family (1F2) to Commercial (C) on property described as Lots 15 – 30, Block M; and Lots 1 – 11 & 29, Block L, Kings Creek Addition, Terrell, Texas, and

**WHEREAS**, the City Council of the City of Terrell, Texas held a public hearing on January 18, 2000, on request to change the zoning from Single-Family (1F2) to Commercial (C) on property described as Lots 15 – 30, Block M; and Lots 1 – 11 & 29, Block L, Kings Creek Addition, Terrell, Texas, and

**WHEREAS**, the City Council has determined that all notice requirements have been given in compliance with the laws and ordinances of the City of Terrell; and

**WHEREAS**, the City Council of the City of Terrell, Texas has determined that it would be in the best interest of the citizens of Terrell to change the zoning from Single-Family (1F2) to Commercial (C) on property described as Lots 15 – 30, Block M; and Lots 1 – 11 & 29, Block L, Kings Creek Addition, Terrell, Texas.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Terrell, Texas:

**THAT** the zoning classification be and is hereby changed on property legally described as Lots 15 – 30, Block M; and Lots 1 – 11 & 29, Block L, Kings Creek Addition, Terrell, Texas, from Single-Family (1F2) to Commercial (C).

**ARTICLE II.**

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

**ARTICLE III.**

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionally shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this Ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph, or section.

**ARTICLE IV.**

This Ordinance will take effect immediately from and after its passage and the publication of the caption, as the law in such cases provides.
