

RESOLUTION NO. 715

A RESOLUTION CANVASSING THE ELECTION RETURNS AND DECLARING THE RESULTS OF AN ELECTION HELD ON MAY 12, 2012, IN TERRELL TEXAS, FOR THE PURPOSE OF ELECTING COUNCIL MEMBERS FOR DISTRICT 2 AND DISTRICT 4 OF THE CITY OF TERRELL, TEXAS, TO SERVE A THREE (3) YEAR TERMS

WHEREAS, heretofore, the City Council of the City of Terrell, Texas, adopted a Resolution calling an election to be held in said City on May 12, 2012, for the purpose of electing members to serve on the City Council of the City of Terrell, Texas, in the positions of Council District 2 and council District 4; and

WHEREAS, the Council Member for District 2 and Council Member for District 4 are to be elected for a term of three (3) years; and

WHEREAS, said election was duly held at the time and at the places specified in the Resolution after due notice as required by law had been given, and;

WHEREAS, there were cast for District 2 at said election a total of 306 ballots and;

WHEREAS there were cast for District 4 at said election a total of 153 ballots and;

WHEREAS, only the qualified electors of the City of Terrell, Texas, were allowed to vote in said election:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TERRELL, TEXAS:

The Municipal Election scheduled for May 12, 2012, was duly called and notice was given in accordance with the law and in accordance with the Resolution calling for said election.
